EMERGENCY OVERVIEW

Suitable fire extinguishing media:

Use water spray, fog or foam.

Specific hazards arising from the chemical:

Flammable liquid. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. Runoff to sewer may create fire hazard.

Hazardous thermal decomposition products:

Carbon Dioxide, Carbon Monoxide

Specific fire-fighting methods:

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Move containers from fire area if this can be done without risk. Use water spray to keep fire-exposed containers cool.

Special protective equipment for fire fighters:

Stop all leaks. Isolate hazard area. Keep unnecessary and unprotected personnel from entering. Eliminate all ignition sources. Disperse vapors with water spray. Prevent runoff from entering drains, sewers, streams or other bodies of water. Absorb spill with inert material. Absorb unrecoverable product. Transfer contaminated absorbent, soil and other materials to containers for disposal.
